### **Copyright Laws**

We are reinventing the laws of copyright. Our main goals are to ensure that proper credit is given to any new, original ideas, onsidering them the property of their inventer, which gives all the inventers the right to establish whatever price for their work. The resulting issue is that a gap is made between those who can or cannot afford access to information. We have thus attempted to enhance the availability of information in areas where people might not afford it.

# What is copyright?

Copyright protect the intellectual standing and economic rights of creators and publishers of all literary, dramatic, artistic, musical, audiovisual and electronic works. Only original ideas can be copyrighted, and these would have to be introduced into a database in order under the copyright protection. Therefore, in order to copyright an idea the first step that is taken is to verify the originality of the idea, after which copyright credits are granted for ever.

### How does it work?

Copyright is intended encourage and give credit to inveners. This is why companies have the right to set their own prices for their products. The market would force these price to be realistic though, as if a product is too expensive the obvious result would be that it would not be bought. This may seem an utilitarian approach, since most of the world would have access to information, but there are still some reions of the world where most people could not afford the prices for a bok or a movie.

# **Committee for Clinical Drug Trials**

### **Thought Process**

Our group was charged with the responsibility to create rules to regulate clinical trials of a new drug: KCSB. This drug, taken as a pill, is similar to Ritalin. It lowers the bodies arousal so as to increase everyday performance. All of the side effects are merely minor infractions and the medicine itself is not life threatening. When deciding on the rules for the tests, we were sure to keep in mind the ethical issues and philosophies that are important to such tests. We decided to take a viewpoint that supports utilitarianism and contractarianism.

#### **Philosophies**

Everyone who tests this drug must be 18 years old or older and must sign a contract that allows them to drop out of the testing at any point if they feel the need to. This agreement falls under contractarianism. The contract also supports the positive rights of the people. A positive right implies a requirement that the holder of this right be provided with whatever one needs to pursue one's legitimate interests. Our drug will allow a person to do that by increasing the performance of the person, which in turn allows a person to fulfill their interests. Human flourishing is often described similarly to positive rights, although human flourishing is more of an action than a right. Kant's description of imperfect duties can also be fulfilled by this drug. Imperfect duties are duties to develop one's talents where the individual has the latitude to fulfill this duty using many different means. This drug is simply one more mean.

Utilitarianism also comes into play with our regulations concerning this drug. We encourage people to volunteer by explaining to them that their efforts will help benefit the greater good by helping us to find a more efficient and beneficial drug for the public to use. ### **Security and Virus Protection**
