Even though the pure λ -calculus consists only of λ -terms, we can represent and manipulate common data objects like integers, Boolean values, lists, and trees. All these things can be encoded as λ -terms.

1 Encoding Common Datatypes

1.1 Booleans

The Booleans are the easiest to encode, so let us start with them. We would like to define λ -terms to represent the Boolean constants true and false and the usual Boolean operators \Rightarrow (if-then), \wedge (and), \vee (or), and \neg (not) so that they behave in the expected way. There are many reasonable encodings. One good one is to define true and false by:

true
$$\triangleq \lambda xy. x$$
 false $\triangleq \lambda xy. y.$

Now we would like to define a conditional test if. We would like if to take three arguments b, t, f, where b is a Boolean value (either true or false) and t, f are arbitrary λ -terms. The function should return t if b =true and f if b =false.

if
$$= \lambda btf$$
. $\begin{cases} t, & \text{if } b = \text{true}, \\ f, & \text{if } b = \text{false}. \end{cases}$

Now the reason for defining true and false the way we did becomes clear. Since true $t f \xrightarrow{1} t$ and false $t f \xrightarrow{1} f$, all if has to do is apply its Boolean argument to the other two arguments:

if
$$\triangleq \lambda btf \cdot btf$$

The other Boolean operators can be defined from if:

and
$$\triangleq \lambda b_1 b_2$$
. if $b_1 b_2$ false or $\triangleq \lambda b_1 b_2$. if b_1 true b_2 not $\triangleq \lambda b_1$. if b_1 false true

Whereas these operators work correctly when given Boolean values as we have defined them, all bets are off if they are applied to any other λ -term. There is no guarantee of any kind of reasonable behavior. Basically, with the untyped λ -calculus, it is garbage in, garbage out.

1.2 Natural Numbers

We can encode natural numbers \mathbb{N} using *Church numerals*. This is the same encoding that Alonzo Church used, although there are other reasonable encodings. The Church numeral for the number $n \in \mathbb{N}$ is denoted

 \overline{n} . It is the λ -term λfx . $f^n x$, where $f^n = \underbrace{f \circ \cdots \circ f}_n$ denotes the n-fold composition of f with itself:

$$\overline{0} \triangleq \lambda f x. x
\overline{1} \triangleq \lambda f x. f x
\overline{2} \triangleq \lambda f x. f(f x)
\overline{3} \triangleq \lambda f x. f(f(f x))
\vdots
\overline{n} \triangleq \lambda f x. \underbrace{f(f(\dots(f x) \dots))}_{n} = \lambda f x. f^{n} x$$

We can define the successor function inc as

$$\operatorname{inc} \triangleq \lambda n f x. f(n f x).$$

That is, inc on input \overline{n} returns a function that takes a function f as input, applies \overline{n} to it to get the n-fold composition of f with itself, then composes that with one more f to get the (n+1)-fold composition of f with itself. Then

$$\begin{aligned} &\operatorname{inc} \overline{n} = (\lambda n f x. \, f(n f x)) \, \overline{n} \\ &\xrightarrow{1} \lambda f x. \, f(\overline{n} f x) \\ &\xrightarrow{1} \lambda f x. \, f(f^n x) \\ &= \lambda f x. \, f^{n+1} x \\ &= \overline{n+1} \end{aligned}$$

We can perform basic arithmetic with Church numerals. For addition, we might define

$$\mathsf{add} \triangleq \lambda m \, nfx. \, mf(nfx).$$

On input \overline{m} and \overline{n} , this function returns

$$(\lambda m n f x. m f(n f x)) \overline{m} \overline{n} \xrightarrow{1} \lambda f x. \overline{m} f(\overline{n} f x)$$

$$\xrightarrow{1} \lambda f x. f^{m}(f^{n} x)$$

$$= \lambda f x. f^{m+n} x$$

$$= \overline{m+n}.$$

Here we are composing f^m with f^n to get f^{m+n} .

Alternatively, recall that Church numerals act on a function to apply that function repeatedly, and addition can be viewed as repeated application of the successor function, so we could define

$$add \triangleq \lambda mn. m inc n.$$

Similarly, multiplication is just iterated addition, and exponentiation is iterated multiplication:

$$\operatorname{mul} \triangleq \lambda m n. m (\operatorname{add} n) \overline{0}$$
 $\exp \triangleq \lambda m n. m (\operatorname{mul} n) \overline{1}.$

Other useful arithmetic operations and tests are easily encoded and are left as exercises.

1.3 Pairing and Projections

Logic and arithmetic are good places to start, but we still are lacking any useful data structures. For example, consider ordered pairs. It would be nice to have a pairing function pair with projections first and second that obeyed the following equational specifications:

$$\operatorname{first}(\operatorname{pair} e_1 e_2) = e_1$$
 $\operatorname{second}(\operatorname{pair} e_1 e_2) = e_2$ $\operatorname{pair}(\operatorname{first} p)(\operatorname{second} p) = p,$

provided p is a pair. We can take a hint from if. Recall that if selects one of its two branch options depending on its Boolean argument. We can have pair do something similar, wrapping its two arguments for later extraction by some function f:

$$pair \triangleq \lambda abf. fab.$$

Thus pair $e_1 e_2 \to \lambda f$. $fe_1 e_2$. To get e_1 back out, we can just apply this to true: $(\lambda f. fe_1 e_2)$ true \to true $e_1 e_2 \to e_1$, and similarly applying it to false extracts e_2 . Thus we can define

first
$$\triangleq \lambda p. p$$
 true second $\triangleq \lambda p. p$ false.

Again, if p is not a term of the form pair ab, expect the unexpected.

1.4 Lists

One can define lists $[x_1; ...; x_n]$ and λ -terms corresponding to the OCaml list operators List.cons (::), List.hd, and List.tl. We leave these constructions as exercises.

1.5 Local Variables

One feature that seems to be missing is the ability to declare local variables. For example, in OCaml, we can introduce a new local variable with the let expression:

$$let x = e_1 in e_2$$

and the scope of x is e_2 . Intuitively, we expect this expression to evaluate e_1 to some value v and then to replace occurrences of x inside e_2 with v. In other words, it should evaluate to $e_2\{v/x\}$. But there is a λ -term that behaves the same way:

$$(\lambda x. e_2) e_1 \rightarrow (\lambda x. e_2) v \xrightarrow{1} e_2 \{v/x\}.$$

We can thus view the let expression let $x = e_1$ in e_2 as syntactic sugar for $(\lambda x. e_2) e_1$.
