## QUESTION 1:

Given a square matrix  $A \in \mathbb{C}^{n \times n}$  and QR factorization A = QR is such a factorization unique? (i.e., are there some other unitary and upper triangular factors  $Q_2 \neq Q$  and  $R_2 \neq R$  such that  $A = Q_2R_2$ ). Justify your response and comment on the implications of it from your perspective, e.g. does your answer make such factorizations less useful?

### QUESTION 2:

Let  $V \in \mathbb{C}^{m \times n}$  with  $m \geq n$  have orthonormal columns, prove the following:

- For any  $x \in \mathbb{C}^m$ ,  $VV^*x$  is the unique closest point in the range of V to x.
- $\bullet$  Prove that the orthgonal projector (also often referred to as the spectral projector) onto the range of V is unique.

### QUESTION 3:

Given any  $A \in \mathbb{C}^{m \times n}$  with  $m \geq n$ ,  $b \in \mathbb{C}^m$  and  $\operatorname{rank}(A) < n$  prove that the solution to the least squares problem

$$\min_{x} \|Ax - b\|_2$$

is not unique.

### QUESTION 4:

For square non-singular A implement the computation of a QR factorization via Householder triangularization. This now gives an additional means for solving linear systems Ax = b. For the following you may use your existing code for computing LU decompositions with partial pivoting.

• Compare and contrast the runtimes of your QR factorization and your LU factorization with partial pivoting. As part of this, show your implementation of Householder QR is  $\mathcal{O}(n^3)$ .

• Build a set of problems that are increasingly ill-conditioned (one way to approach this is to explicitly define the desired singular values via a diagonal matrix and then use random orthogonal matrices to generate a matrix, that it not itself diagonal, with the singular values you want) and explore the relationship between the condition number of the problem and the accuracy in the solution of Ax = b using your QR factorization routine.

QUESTION 5 (UNGRADED BUT FUN, AND MAYBE A GOOD EXAM WARM UP...):

Say we would like to compute a QR factorization of  $A^k$  for some real, square A and potentially large integer k.

- Even if feasible to simply construct  $A^k$  would it be good idea numerically to compute its QR factorization directly? Justify your response. Hint: assuming A is diagonalizable, what can we say about the eigenvalues of  $A^k$  and what are the implications of this.
- Develop a scheme to compute a QR factorization of  $A^k$  via a sequence of k QR factorizations of matrices whose condition number is never larger than that of A itself. As long as you adhere to this constraint, for the purposes of this problem you may assume that computing matrix matrix products with the resulting Q and/or R is fine numerically. Hint: start with a QR factorization of A itself.
