

# CS1115 Lab 4 (September 19, 2013)

## 1 Different ways to create vectors

Type the following expressions in the MATLAB *Command Window* to see what kind of vectors they create. Write the resulting vectors (and answer the questions) on the blanks.

```
a= zeros(1,4) %_____
b= zeros(4,1) %_____ What do the arguments specify?_____
c= ones(1,3) %_____
d= 10:2:17 %_____
f= 10:-1:17 %_____
g= [10 20 40] %_____ What does the space separator do?_____
h= [10,20,40] %_____ What does the comma separator do?_____
k= [10;20;40] %_____ What does the semi-colon separator do?_____
m= [a g] %_____
n= [b; k] %_____
p= [a k] %ERROR--mismatched dimensions! (Attempt to concatenate a column to a row)
q= b' %_____ This operation is called "transpose"
r= [a b'] %_____
```

## 2 Built-In Functions and Vectors

Using `help` and the following small examples, figure out what the built-in functions do: `rand`, `randn`, `max`, `min`, `sum`, `sort`

```
x = rand(1,4)
x = rand(4,1)
y = randn(1,4)
s = sum(y)
M = max(y)
[M,i] = max(y)
m = min(y)
[m,i] = min(y)
z = sort(y)
```

Describe in English what the following commands do, assuming that `x` is an initialized vector. Check out your reasoning by running the commands on small examples.

```
y = x - sum(x)/length(x) % Example 1
y = sqrt(sum(((x + abs(x))/2).^2)) % Example 2
t = sum(sin(x).^2 + cos(x).^2)/length(x) % Example 3
```

### 3 Plotting Relative Error

From the syllabus page, download `MySqrt` and `MySqrtErr`.

```
% Script MySqrtErr
n = 1000;
x = logspace(0,6,n);
relErr = zeros(1,n);
for k=1:n
    Approx = MySqrt(x(k));
    True   = sqrt(x(k));
    relErr(k) = abs(True - Approx)/True;
end
loglog(x,relErr,'.')
axis([a b 10^-18 10^1])
shg

function s = MySqrt(A)
% A is a positive real scalar
% s is an approximation to its square root
L = A; W = 1;
for k=1:10
    L = (L+W)/2;
    W = A/L;
end
s = L;
```

(0) Run `MySqrtErr`. (1) Play with the loop bound in `MySqrt` and observe the effect. (2) How does `logspace` work? What is `logspace(-3,4,8)`? What is `logspace(0,1,2)`? (3) Instead of `loglog`, what if we used `plot`? What if we used `semilogy`? (4) In MATLAB, `eps` is a built-in constant. What is it? Modify `MySqrt` so that the averaging process runs until `abs(L-W)/L < eps` and rerun the original `MySqrtErr`. (5) Play with the `axis` command and figure out what `axis(v)` does where `v` is a length-4 vector. (6) Figure out what `shg` does by removing it from `MySqrtErr` and then running the resulting script.

### 4 Finished Early?

The number ways a set of  $n$  objects can be partitioned into  $m$  nonempty subsets is given by

$$\sigma_n^{(m)} = \sum_{j=1}^m \frac{(-1)^{m-j} j^n}{(m-j)! j!}.$$

It is not obvious but the summation always renders an integer as long as  $1 \leq m \leq n$ . For example,

$$\sigma_4^{(2)} = \frac{(-1)^{2-1} 1^4}{(2-1)! 1!} + \frac{(-1)^{2-2} 2^4}{(2-2)! 2!} = -1 + 8 = 7.$$

Thus, there are 7 ways to partition a 4-element set like  $\{a, b, c, d\}$  into two non-empty subsets:

```
1 : {a},{b,c,d}
2 : {b},{a,c,d}
3 : {c}, {a,b,d}
4 : {d},{a,b,c}
5 : {a,b},{c,d}
6 : {a,c},{b,d}
7 : {a,d},{b,c}
```

Note that  $\sigma_n^{(1)} = \sigma_n^{(n)} = 1$ . Implement a function `Subset(n,m)` that returns the value of  $\sigma_n^{(m)}$ . Use `Subset` to print a table with 10 lines. On line  $n$  should be printed the numbers  $\sigma_n^{(1)}, \sigma_n^{(2)}, \dots, \sigma_n^{(6)}$ .
